On a beautifully clear and still morning recently I was sitting at my desk and heard chanting out on the lake. Three waka were out with a group of local school children; this is always a sign that the holidays are rapidly approaching.

### **Tarawera Sewerage Scheme**

On 30 October, Glenn Snelgrove and I attended a meeting at Rotorua Lakes Council to receive the Cultural Impact Assessment (CIA). Since that meeting we were advised that:

- Rotorua Lakes Council (RLC) is putting together a response to the CIA recommendations – especially the feasibility of a Waste Water Treatment Plant at Tarawera
- RLC clarified with Bay of Plenty Regional Council (BOPRC)
   that uncertainty regarding septic tanks involves 20
   properties not (170) as stated in the CIA. BOPRC has taken
   further inspections and have issued necessary direction to

those properties

- RLC is trying to identify a suitable time to meet with Mana Whenua to go over the CIA report and its responses. Timing at the moment is unclear.
- Following the meeting, the Project Team will convene a joint meeting to chart moving to an agreed option confirmation and means to inform the community, before detailed design commences.
- RLC will be seeking updates on this during their Draft Annual Plan

### **Power Pole Replacement**

You will have noticed that work is well underway with the replacement of poles on Tarawera Road and the first part of Spencer Road.

We have been in touch with Unison Networks about undergrounding of the power poles and a representative from Unison will give us an update at the AGM.

### **Tarawera Pest Control Fundraising Event**

On Saturday 26 October we held the Tarawera Pest Control fundraiser at Black Barn. A very big thank you to Glenn and Shelly Barbour for their generosity. The feedback that we have received has been extremely positive and we have been asked numerous times if we will be hosting further events like this—we hope so.

The only downside of the evening was the rugby score ...

We were delighted with the results of both the live and silent auctions and we raised well in excess of the \$6,000.00 that is required to provide rat traps for the foreshore along Spencer Road.

Lookout pests—you are being targeted!

### **Tarawera Landcare**

We were very grateful to receive 500 trees from Bay of Plenty Regional Council. On the 9<sup>th</sup> November we had a planting day and with a good number of volunteers we managed to get most of the trees planted. The following day there was torrential rain, which was great, and hopefully before Christmas we will have a pipeline across Kariri Point so that we can water the trees when it is really dry. The

Trustees were very happy for us to install the pipeline, as they said it would be terrible to see these trees die.

### **Transfer Station**

After Labour Weekend there was a terrible mess at the transfer station and I met with Smart Environmental to find a solution to the problem of too much rubbish. They are now coming out each day to check and clear the transfer station if necessary.

There continues to be some very selfish people who think that they can dump anything there. The 24 hour service we have is for rubbish bags only – not for garden rubbish; recently one container had a huge pieces of bamboo sticking out.

I had a conversation again on Tuesday 3<sup>rd</sup> December with Smart Environmental and I was advised that a new camera is to be installed at the transfer station. This camera can be monitored 24 hours a day and there will be a facility that allows Smart to speak to anyone who is dumping rubbish illegally.

# Lake Tarawera Pest Control: December 2019

I said in the last posting that the rats hadn't given up and this is most certainly true given our bait usage. Compared to the five year average, bait usage for this time of year is at least 28 % up. On my own bait stations I can see the bait usage continuing when normally alternative food sources would have taken the rodents on holiday. I think it is mostly due to a mild winter where rodent populations have remained at higher levels than normal.

Regardless of the analysis, it means there are rodents around just busting to get inside your house, shed, pantry, or all of the above and we need to maintain our baiting regime to at least put a lid on the population.

Last month's charity fundraiser in aid of Lake Tarawera Pest Control was a huge success, the funds being allocated specifically for the installation of a line of rodent traps along the length of the lakefront walkway. I am pleased to say we raised more than enough money to do this but ... there usually is a but somewhere ... because the traps are both close to the lake and in a public environment there are a number of boxes to tick that fall broadly into the Health and Safety space, before we can commence.

### Our Plan is to install from 60 to 100 traps. One every 100 metres along the walkway

- They need to be traps (Victor and DOC series treadle traps), not bait stations given the potential for bait to enter the lakeshore environment
- Enclosed and tamperproof
- Under National Animal Welfare standards (they do apply to rodents) the traps must kill humanely
- GPS located and individually named and marked
- There are parts of the walkway that will need to be cleared and joined up to make the task of track checking easy, if it isn't easy it won't get done

There are other issues as well, this is why you haven't seen a slew of traps dotting the foreshore. I am not sure if we buy off the shelf or make a suitable trap enclosure. We have a specific requirement that doesn't seem to have an off-the-shelf solution. I am just about ready to go out to the wider world and issue a set of specs to see if someone has got a solution. I have some ideas, however, I think collectively we can come up with something that will work.

### Wasps

I have been asked by lots of people what we are doing about wasps. There is really only one tool in the toolbox and that is VESPEX, this is a wasp targeted bait that has been very successful, however, it requires monitoring to only bait at the correct time or it is all a waste of time. To make this work it will (Continued on page 5)

require a lot of community involvement as we will need about 100 bait stations to run the length of Spencer Rd. If there is enough support we will use some of the Charity Fundraiser proceeds to fund this program in Jan / Feb of 2020. Still on wasps if you find any wasp nest can you contact me on rats@eol.co.nz and I will organise for the nest to be exterminated.

# Why? David Walmsley

We genuinely care about our environment and try to do our best to maintain a level of care. In many cases we try and improve it or have an aim to get it back to a better state for us and future generations. A good example of this is the massive commitment to the restoration of our lakes and similar projects. Great efforts are made by dedicated locals to minimise the effect of the out of control foreign plants and pests around Lake Tarawera also.

So why do some people not care about these things?

Every second day my friend Graeme and I walk along Tarawera Road from the Buried Village to the Blue Lake lookout for our morning exercise. And every day (especially after the weekend) we are constantly bending over picking up the discarded rubbish from people visiting the lake. You can guess the type of people doing it by the type of rubbish they throw out of their cars. Soft drink cans, RTD mix cans, small beer bottles, takeaway packaging and disposable coffee cups etc.

My final frustration came around the Tarawera lookout. Over the last few months we have gone through a process of reprinting the lookout panels that tell the stories of Tarawera. We graffiti guarded the panels and reframed them with aluminum edging including glue mounting them back in place. Within weeks three of the panels have been attacked by someone with a knife and keys. With hundreds of visitors stopping there each year to enjoy the view and learn a little about the history of Tarawera, what does that say about us.

I do acknowledge the issue is not unique to here.

What do these people get out of it? Is it a lack of self-esteem? Does it make them feel better somehow? If I could answer that maybe I could see a way of changing this attitude.

# Lake Tarawera Fire Unit: Susan Cutler

Summer weather is heating up and with it comes the usual fire risk. The Pumicelands fire risk level board on Tarawera Road has already reached Moderate several times in the last month, and in some places in the region has reached High. Although there has been rain, the wind has contributed considerably to this rise.

### Reminder

**Open fires cannot be lit anywhere around the lake - this includes the three DOC campsites.** If you see a fire when you are out on the lake, advise the people concerned that it is not allowed. Fires must be completely extinguished and reported to DOC and Fire and Emergency via a 111 call.

The Fire Permit notice is printed on the following page. The website clearly explains the process and is simple to follow. *Please read it and check before you light up.* 

### Training

A number of our crew have attended the following courses recently:

Working with Aircraft [safety around helicopters, loading and exiting, and filling monsoon buckets;] Management and Leadership; Participating at a controlled house burn; CIMS [Coordinated Incident Management System - Civil Defence procedures and planning;] Respect and Inclusion. Steve Gatenby, our 2IC, had the opportunity through his work to go to New South Wales for 3 weeks, working from the helicopter at the fires they are having over there.

### **Orientation of Properties**

Over the New Year period our volunteers are planning to visit properties to gain details of water sources and lake accesses. Locations of water tanks [sizes], streams, etc., and degree of accessibility to the lake, are needed for our maps to aid us in the event of fire callouts.

We will only visit where people are at home and will not wander around your property if you are absent.

### **Smoke Alarms**

Our Fire Unit aims to ensure every house at Lake Tarawera has working smoke alarms. We hope to have pamphlets about these when we visit about the water supplies, if you have any queries.

"When you are asleep, you lose your sense of smell. Don't assume your smoke alarms are working. Press the button to check - monthly."

It is important to make sure you have photoelectric type smoke alarms installed in your home. Alarms have a 10 year lifespan and if they do not have long-life batteries, the batteries must be changed every year.

# **FIRE PERMITS**

In the Lake Tarawera area, there is a restricted fire season all year round. Permits are required for lighting of fires in the open air. There are exceptions with conditions. To check if you require a permit, go to Fire and Emergency **OR** <u>www.checkitsalright.nz</u>

Allow at least three to five days for application process and possible site inspection.

The Rotorua Lakes Council have not sent out a letter with a voucher for rubbish bags this

year. However you may collect them from Smart Environmental's office at 24 Te Ngae

Road opposite Countdown.

<u>These bags are free</u>; if you don't have a rates invoice they will check on their data base to see if you are entitled to free bags.

# Tarawera Landcare (TLC2115): Pete Fahey

I've been reflecting on the last twelve months and the progress in that time. We've been very effective in our fundraising efforts to date. We took possession of a brand new 500cc Honda Pioneer (now officially known as Rhonda) as well as a trailer. This purchase was funded from a combination of sources including the RLC Neighbourhood Matching Fund, the 'Ratties' and the LTRA. Rhonda has proven to be a very useful tool and contributed greatly to the effectiveness of the monthly working bees.

BOPRC in the form of Shane Hona, has been incredibly supportive of our work and have provided 500 native plants, agrichemicals, equipment, aerial mapping and advice to help with the work we are doing.

The Sir John Logan Campbell Residuary Trust has provided us with \$20,000 for use on Kariri Point. Most of this is directed to ridding the point of Acacia trees. We will be putting in another application for funding prior to September 2020.



The trustee owners of Te Rua a Umakaria Trust have been very supportive. We have been very careful to keep them in the communications loop so that they know what is going on every step of the way.

Our working bees on Kariri Point have been very well attended and I have noticed, particularly of recent times, a great community spirit and 'ownership' of this special project.

I must say that the morning teas are becoming a particular highlight as the ladies compete for bragging rights and last Saturday's was no exception ... Christmas cake, cheese scones with homemade jam, lemon cake, raspberry and blueberry muffins. Great for those attending and those that don't show up are missing a treat not to mention extra calories.

Of very recent times we have planted out 450 native plants on the Point which are doing exceedingly well in the month they have been in the ground, although there has been some well-timed rain in between times. We are about to install an irrigation system to keep things moist over the summer and thus ensure their survival.

# Lakes Water Quality Society Update: Don Atkinson

On November 7-8, we held our "Float the Boat – Certify" Symposium. Excellent papers were presented over the two days by leaders in their field. The principal theme was putting the case for better biosecurity through self certification. NIWA provided the history and spread of pests in our lakes. Doctor



Lars Anderson from California, provided a valuable contribution on how they are preventing the spread in the USA, with the main focus on Lake Tahoe. There, using a token system they have prevented further pest incursions for over 10 years. A further example of biosecurity in New Zealand was given in the Fiordland area.

The case was well made and supported for our proposed certification requiring all boat trailers and equipment to be checked, cleaned, drained and dried before launching. To achieve this, legislative change to the Biosecurity Act will be required to enable infringement notices to be issued and instant fines attached. To this end we heard that the Act is currently in review so this is timely. In addition BOPRC's Regional Pest Plan needs to be inclusive of a Rule change; this is currently in process.

An educational programme has commenced and we anticipate seeing a lot more activity around boat launching this year.

The complexity around the Tarawera 8 Lakes System was revealed by Chris McBride. The best opportunity for funding wallaby control is through the Regional Development Fund, this was signalled by both Minister David Parker and Guy Salmon.

Lake Rotoehu algae blooms came under focus and alternative alum dosing explored. Let's hope this can be implemented to provide respite while the land use changes have the necessary time to kick in.

AGM date for 2020 is Auckland Anniversary Day January 27<sup>th</sup> at 10am at the Pikiao Rugby League Club, Mourea.

All welcome, casual lunch provided. We look forward to seeing you on the day. We will provide the highlights of the symposium; Regional Council will provide updates for their programmes and it will be an opportunity for you to bring to our notice your concerns. We anticipate good representation from both Councils.

## Bay of Plenty Regional Council: Lucas MacDonald

Kia ora koutou, The Bay of Plenty Regional Council has undertaken a programme of pest fish monitoring in the Rotorua Te Arawa Lakes over recent months. The process involves collecting water samples and analysing the DNA sequence for the presence of aquatic pests. Also known as eDNA testing, this new method complements existing techniques such as netting and visual surveys, and is another tool which allows us to detect invasive species.

The Bay of Plenty Regional Council undertook sampling for all known invasive pest fish and plant species in New Zealand at the Rangiuru Bay Boat Ramp, Lake Tarawera in August 2019 using the eDNA testing method. No new pest incursions were observed in the results.

The eDNA testing is also able to detect other fish and terrestrial animals which had a DNA presence in the samples taken. The results of the testing are summarised below and provide an interesting insight into what is present in our lakes. We intend to continue using this cost effective and informative method of testing going forward.

### Species Detected at Rangiuru Bay Boat Ramp

- Daphnia galeata (water flea)
- Fulica atra (eurasian coot)
- ♦ Gobiomorphus cotidianus (common bully)
- Hydra vulgaris, hydra viridissima and astrohydra japonica (water polyp)
- Retropinna retropinna (smelt)
- ♦ Craspedacusta sowerbii (freshwater jellyfish)
- Cygnus atratus (Black Swan)
- ♦ Todiramphus sanctus (Sacred Kingfisher)
- Trichosurus vulspecula (common brushtail possum)

No new pest fish incursions were detected in the sample including catfish, perch, tench or rudd or koi carp. The Cyprinidae family was detected and this is likely indicative of wild goldfish which are widespread in the Rotorua Te Arawa Lakes.

Twelve DNA signals were detected to species level, with many results to genus and family level. Genus and family detections indicated the presence of freshwater snails, bullies and trout.



My aim is to leave it here and pop back and forth from Tauranga for three or four night stints of exploring the lake with my family. Please call Brent on 022 494 0726.







# **Introducing Your LTRA Committee Members**

### **COMMITTEE MEMBER (& TREASURER): DON STEWART**

I first came to Tarawera in the early 1950s to stay at my grandfather Harold Thomas's cottage situated at Waitangi Bay. This cottage was relocated to the point on the south side of the bay and still stands today.

Childhood memories are of the long drive from Auckland, the dusty corrugated pumice road, then spending many weeks with my siblings and cousins, swimming, enjoying the bush, catching tadpoles, eels, then trout, and graduating to be allowed to use the seagull outboard.



Occasionally there was a trip across the lake to the Outlet or Hot Water Beach, in my grandfather's launch, which was usually a day long excursion, sometimes with a rough home trip against the afternoon northerly breeze. This reminds me of a time in the 1960s when a group of 5-10 of us were dropped off at the Outlet by boat by parents.

We were to traverse the mountain and be collected late afternoon inside the Te Ariki arm. A fierce northerly storm arrived and we made our way down in almost zero visibility. The waves were like surf rolling into the arm and we made a bivouac and luckily got a fire going under the acacia trees, spending a long night. The tourist launch Reremoana appeared at first light after the storm abated, with a bedraggled parent on board and his runabout in tow. We then learned of the drama of the parent having set out to collect us, being washed ashore at Twin Streams, spotted by an aeroplane, and a major panic erupting. The launch had one attempt to tack right across to the lee of the Humphreys shore to be able to turn towards the arm, then gave up because the waves were too large, having to wait until the storm died down early morning. A real lesson on how quickly the lake can rough up, as was witnessed in June 2018 when many jetties were destroyed.

I developed a love for trout fishing, landing my first double figure fish at Waitangi Stream when I was (Continued on page 24) (Continued from page 23)

10 years old, and later, a love of hunting, after I became a permanent resident.

In 1980 we decided to move to Tarawera permanently. Having spent a couple of years overseas after getting married, and then another couple of years back in Auckland, Clare and I found ourselves more and more attracted to Tarawera. We rented a house for two years at Te Toroa Drive, then purchased land at 295 Spencer Rd where we built our house.

Over the past almost 40 years, we have



had a wonderful lifestyle, with three of our four children being born at the lake, and me establishing a Chartered Accounting practice in a provincial town. Clare was mainly running around after the children in the early years, but later on resumed her nursing career, with stints as a Practice Nurse, and also in theatre at the hospital. She also spent some time as my receptionist, and was the best Credit Controller we have ever had!

I have had at least three terms as a committee member of LTRA, from the days of Maurice Scobie and fighting for Makatiti Dome reserve, Barry Prior and averting a large development at Kariri Point, to the current time when water quality and sewerage reticulation are the main issues.

We recently moved into Rotorua, mainly due to health reasons, but still have an option to return when I fully retire. Our son Dane and his family have purchased our family home, having also moved from Auckland, and their children have now become the fifth generation to have lived at Waitangi Bay since my grandfather purchased the property in 1946.

My "happy place" is either sitting on our old deck, or drifting in the boat under the pohutukawas, gazing at the lake and mountain and listening to the bellbirds, which to me has always been the sound of Tarawera.


My father had a long, happy relationship with
