Cell Phone Tower

On Monday, 7 December, Rotorua Lakes Council granted Resource Consent to the Rural Connectivity Group for the construction of the Rural Broadband initiative 2 (RBI) cell site to provide coverage to Lake Tarawera and the Buried Village. This is a project that has overcome many hurdles, over many years, and the RCG has now scheduled the build of the facility to start in the second week of January 2023.



Lake Tarawera Pest Control

1. Wasps

Lets start off with wasps as they are about to become a nuisance. First, a little etymology lesson.

We have two predominant pesky wasps here:

The Asian Paper Wasp: These are the ones that build nests dangling under your eaves, the nest never gets much larger than a billiard ball and is always visible. They don't swarm and are not a pest until you really annoy them when they **will** sting you.



Their abdomen has thin yellow bands opposed to large patches of yellow and they appear skinny when compared with the German or common wasp.

German and common wasps: These are the wasps we are worried about; they are the ones that cause us trouble. They swarm, they sting you and they are constantly angry.



I have killed plenty of wasp nests and they are always in the ground or close to ground level; the wasps are angry and ready to defend their HQ. The good news is we can easily kill the nests with pyrethrum powder but the hardest part is finding the nest. Lots of people collar me and say they have wasps and I ask if they know where the nest is and they don't, they just know there are annoying wasps about.

If you know where the nest is I can easily deal to it and now with the help of the LTRA we have a BEE suit that allows me to get right up close to deliver the killer dust into the throat of the nest rather than the previous method of dump and run like hell and hope the powder was delivered correctly.

We also have a network of bait stations (like this) using a wasp-specific bait, Vespex. These are done around early March.



If you find a wasp nest text me on 029 575 0943 with the details and I will sort it out.

2. Possums:

Fooled again, I have just found possum signs at Kariri Point so will set up some traps there. If you have possums I can lend you a trap or come and shoot them.

3. Rabbits:

Rabbits are making the most of the pleasant breeding conditions, I have shot about 10 of them and will go out again in the next couple of weeks. Even in my garden we have rabbit browsing damage!!

4. Rats: Just like the rabbits, the rats are out in force and the bait use returns I am getting show they remain a problem. Soon we will be starting our trap line from Otumutu to Cliff Road, which should make a dent in the population at that end of the road. These will be kill traps sited along the formed access way.

## Tarawera Landcare (2115): Pete Fahey

Looks like we're in for a damp Christmas and holiday period however there are some very nice trout in the lake at the moment. I saw a beauty today of 3.8 kg but I digress.

Everywhere I look the growth is rampant. The old man's beard at Kariri Point has a new lease of life but the flip side of that is the incredible growth of the natives we have planted.

But recently, however, I've been thinking of other pests in the area; in particular cats. We go to a lot of trouble to protect the birdlife in our slice of paradise by actively trapping possums and rats as well as

attempting to attack the mustelids (although these, with very little success). But the apex predator of all are the cats: domestic and feral. There are growing calls from various environmental groups for cats to be part of the Predator Free by 2050 plan; controlled initially by desexing and microchipping. I do think we need to have a discussion about where cats fit into the ecology of Tarawera.



#### Things we could do ...

- Let it be known that Tarawera is a 'cat controlled' zone
- Encourage owners to keep their cats indoors at night—dusk till dawn
- Encourage owners to desex and microchip their pets
- Initially trap cats at night and destroy the obvious feral ones
- Conduct a cat census in our area to establish the population
- Let entities like Book a Bach, Airbnb and their users know that if visitors bring their cats on holiday with them it could be a mistake

Anyway, its food for thought and I'd welcome feedback as to the best way to go about this if anyone knows of a better way.

## Te Arawa Lakes Trust (TALT)

#### Uwhi-MāTauranga Māori Solution to the Colonising Pest Problem

Te Arawa Lakes Trust, Te Roopū Raranga Ki Rotorua, iwi and hapū and Toitū Te Whenua - Land Information New Zealand, gathered last month to hear the preliminary results of the Uwhi (harakeke mat) trial.

It has been almost one year since the placement of Uwhi on the lakebeds of Lake Tarawera, Lake Rotoiti and Lake Rotomā to trial the effectiveness of bottom lining with a Te Arawa lens to control aquatic pest weed in Te Arawa lakes.

Te Roopū Raranga Ki Rotorua spoke to the mātauranga that went into creating the three different variations of Uwhi and scientific divers



from Te Arawa Lakes Trust gave an update on how the Uwhi were performing post installation.

Monitoring so far indicates the Uwhi, made from locally sourced harakeke under the guidance of expert weavers, lasts much longer on the lakebed than the imported hessian weed mats used extensively in the South Island lakes. This results in the longer-term control of aquatic pest plants such as *Lagarosiphon major* that is rife at sites like Rangiuru Bay (Stoney Point), Lake Tarawera.

The dive team also observed the natural affinity taonga species such as Koura, Toitoi and Kakahi had for the Uwhi compared to the imported hessian mats and spoke to the relevance of whakapapa species and the importance of Te Arawa to be actively involved in freshwater management.

Not only do the Uwhi perform well as an aquatic pest management tool, but they are also a sustainable, low-cost alternative that have provided employment opportunities for many Te Arawa whānau that lost employment during the Covid-19 pandemic.



Whilst the divers are still monitoring the sites into 2023, its fair to say the project has been a success to date and the future for Uwhi as a potential management tool is yet to be completely harnessed.

For the mana moana and hungatiaki of Lake Tarawera, Tūhourangi (pictured here) and Ngāti Rangitihi, it is hoped that this trial will provide another tool in the kete

to combat aquatic pests and protect taonga species for today and into the future.

Tarawera Impact Collective: Progressing a Collective Impact Framework for the Tarawera Lakes System

Te Arawa Lakes Trust with support from the Ministry of the Environment's Te Mana o Te Wai fund is excited to announce we have almost finished recruiting for the Tarawera Lakes Collective Impact Project and look forward to introducing you to the team in the new year.

In 2023, the team will be responsible for implementing a project that aims to ensure connected action for the health and wellbeing of Lake Tarawera and its seven contributing lakes.

This team will connect, provide support and pursue opportunities to empower Tarawera iwi, Māori Land Trusts, landowners and community care groups to implement projects to ensure that the long-term care of the eight lakes reflects Te Arawa values and incorporates cultural monitoring, practices and mātauranga.

#### Why pursue a Collective Impact Framework for Lake Tarawera?

Central and local government agencies, hapū and iwi, as well as community groups have each been working on projects to improve the health of the land and/or water within the Tarawera Lakes Catchment System. These groups have overlapping aspirations, issues and interests, which include water quality, pest plants and animals, tourism/recreation pressures and opportunities, land use impacts, job creation, ecological health and biodiversity protection.

There is an overwhelming desire for more effective and coordinated action however, this is difficult without additional support, focus and resourcing. Collective impact is a form of collaboration which brings together groups, each with their own set of skills and experiences, to solve large complex problems. In this case, the large complex problem is improving the health and wellbeing of the water and land surrounding Lake Tarawera (and all connected and contributing lakes).

This approach recognises that, within the Tarawera Lakes System, no single organisation can create largescale and long term environmental and social change alone. Therefore, more can be achieved through collective impact, where groups, each with their own set of skills and experiences, are working together for a common purpose.

Ultimately the project will also hope to achieve the vision of the Rotorua Te Arawa Lakes Strategy Group "The lakes of the Rotorua district and their catchments are preserved and protected for the use and enjoyment of present and future generations, while recognising and providing for the traditional relationship of Te Arawa with their ancestral lakes."

#### **Catfish Netting**

Catfish Netting has continued with more kura joining the kaupapa. Schools from Matapihi are most recent additions to the Catfish Killa team. We have even had a visit from a Christchurch Kura recently where they checked nets in Rotorua. Volunteers catfish kills are at 10,603 for the year starting 1 January 2022. With the spawning season well underway, this is only going to increase. Thirty-five schools from around Te Arawa remain involved in the programme and more are signing up to get involved next year.

The Catfish netting contract is in full swing with netting being carried out around Rotoiti In October and November so far. Kaimahi from TALT set 40 nets three times a week at hot spots around Lakes Rotorua and Rotoiti to catch as many catfish as possible. So far, 2,300 catfish have been removed, many of them over 20 cm and in the early stages of spawning.

We will be carrying out surveillance netting in both Lake Ōkataina and Lake Tarawera in February 2023.

## Ground Water Monitoring: Terry Beckett

The University of Waikato has been contracted by the Bay of Plenty Regional Council to measure and report on the benefits of sewerage reticulation in reducing contaminants to Lake Tarawera. This project will commence in January 2023 with the installation of shallow groundwater bores at a number of sites around the lake.

Monitoring of the groundwater in the bores will be undertaken monthly both before septic tanks are decommissioned and after reticulation is completed when the Lake Tarawera wastewater is piped to the Rotorua Wastewater Treatment Plant.

## Tarawera Sailing

First a big thank you to everyone who supported Tarawera Sailing at the Spring Fair. Our current fund raising will go towards a much needed second safety boat. We are very grateful to the community.

The new season began with Registration Day on 20 November. It was good to see our sailors from last season and several new families signing up. We meet on Sundays at 2.00 pm at Cliff Road Reserve.

Over the winter we had a working bee to clean the boat hulls. We have also refurbished our two Spirals. These provide a step up from the Microns as our sailors become more experienced. The Spirals are also a great introductory boat for adult sailors. Our learn to sail fleet for young sailors now numbers nine boats.

We also have eight Lasers available for adult sailors and there are two Laser rigs with a smaller sail area suited to smaller sailors and first timers.

We have had several Sundays of moderate conditions allowing the 'learn to sail' programme to get away to a good, although soggy start. We are very grateful for the crew of helpers on shore and on the water in our safety boat. They play an essential role during Sunday sailing, providing safety supervision, coaching, managing boats leaving and returning to shore, and also rigging and packing up. Many thanks to everyone involved.

We are always on the look out for experienced sailors who can assist with coaching beginner and intermediate sailors and organise short races. There is also opportunity for helpers to get out on the water in our Lasers.

Our last session before we break for Christmas is 18 December and we resume on Sunday, 8 January 2022. For any enquiries, please contact Carol Gilchrist on 07 3628 489.

## BOPRC Harbour Master Update Dec 2022

The wild weather over the past three months has kept us busy replacing many of the navigation aids around the lakes in preparation for the expected busy summer ahead. Lake Tarawera is currently undergoing navigation aid and sign audits, with this work now well underway. In some places around the lake, we are needing to cut back foliage around signs and navigation aid markers, so they are visible.



#### **Abandoned Vessels**



Abandoned vessels are somewhat of a recurring subject in the Bay of Plenty with the Regional Council unfortunately needing to deal with numerous boats every year. Priority is given to those that represent a pollution risk or those that could pose a navigation hazard. Under the Maritime Transport Act, the Regional Council has the powers to remove vessels deemed to be abandoned. Recently our Maritime team pink-stickered a vessel in Boatshed Bay to start the process for removal. Attempts so far to reach the owner have been unsuccessful. Our preference is of course to work with vessel owners to get a positive outcome for the both boat and environment. Please if you can assist with any details on this vessel

#### Lake Debris

While it's been great to see all the lake levels recover with the abundance of rain, most lakes are still

very high, and we have numerous call outs for logs, debris and even personal effects that have floated away from front yards! Please be vigilant when boating around the lakes as some of this debris has the potential to cause significant damage and/or injury if struck at speed. Our team will remove any of these hazards so please let us know! (0800 5knots).

#### Wear Your Personal Floatation Device (PFD)

Tragically this year we have lost two kayakers in separate incidents on the Lakes highlighting the need to carry (and wear) your lifejacket. Conditions can quickly change to be deadly, and it is easy to be caught out. Our patrol



teams this season will be checking every vessel, jet-ski, kayaker and paddleboarder to ensure this rule is being followed. The rules are there to ensure everyone gets home safely!

#### Let Us Know!

The best way to report poor boatie behaviour or any navigational safety matters, is to please call our **0800 5KNOTS** call line. This is a 24/7 service and is worth calling, as often we can redivert our patrols to an incident if we are close by.

#### **Bylaw Review**

The Bay of Plenty Regional Council oversees maritime safety in the region under the Navigation Safety Bylaws required by the Maritime Transport Act (1994). The rules were established to help minimise the risk of fatalities, injuries, nuisance, accidents, collisions, and damage in Bay of Plenty navigable waters.

We are reviewing the Maritime Navigation Safety Bylaws for the Bay of Plenty region with the goal of having updated bylaws by mid to late 2023. The current bylaws have been in place since 2017 and we review them every five years. We are seeking feedback this summer to help guide changes to our bylaws. ## **BOPRC: Pest Management Plan (RPMP)**



#### Check, clean, dry, certify

This summer is the third year that **Rule 7** of the Bay of Plenty Regional Pest Management plan (RPMP) has been in effect. **Rule 7** requires that people using the Rotorua Te Arawa lakes, ensure that their vessel (boat, jet ski or kayak) and trailer are free from freshwater pest weeds and fish before they hit the water.

#### At the majority of boat ramps around the rohe (region), including Lake Tarawera, anyone using the boat ramp must also fill in one of the self-certification forms that can be found in box near the boat ramp.

Biosecurity Officers from Te Arawa Lakes Trust (TALT) will continue to be regularly checking that everyone is aware of, and following the rules. This year there will be an additional focus on ensuring that people leave the completed self-certification forms on the dashboard of vehicles carrying the trailer. Please be a waterway hero this summer and encourage friend's and whānau to check, clean, dry and certify when using the region's lakes.

## Rural Connectivity—New Cell Site

On Monday 07 December Rotorua Lakes Council granted resource consent to the Rural Connectivity Group for the construction of the Rural Broadband initiative 2 (RBI) cell site to provide coverage to Lake Tarawera and the Buried Village. This is a project that has overcome many hurdles, over many years, and the RCG has now scheduled the build of the facility to start in the second week of January 2023. The RCG are working with Unison on the power supply to the facility and have been notified that there is a long delay for power connections to the Unison network. RCG will continue to work with Unison to see if the power connection for the cell site can be prioritized.

The RCG thank the Lake Tarawera and Buried Village community for their unwavering support for gaining connectivity for the community. Discussion about improved connectivity started during the RBI1 programme of work when the cell site at Lake Okareka was built. It is a very pleasing for all involved that the project will now come to fruition.

Please note that the Lake Tarawera facility is a 4G only cell site including making voice calls using the 4G network. Residents need to check with their provider that their mobile phone is 4G voice calling capable. There are different models of phone on each network that are capable of 4G voice calling or 4GVoLTE.
